PLAYER AUTHORIZATION, WAIVER AND GENERAL RELEASE FORM

As the parent or legal guardian of the child named below, I hereby give my full consent and approval for my child to participate in the sport designated on the Lynbrook Titans registration form. I hereby certify that my child is fully capable of participating in the designated sport and that my child is healthy and has no physical or mental disabilities or infirmities that would restrict participation in this activity. I understand that participation in the practice and play of this sport exposes my child to a possible risk of serious physical injury, as does traveling and other related activities incidental to my child's participation.

In addition to giving my full consent for my child's participation, I, on behalf of myself, my spouse, children, legal representatives, heirs, successors and assigns, willingly accept and assume responsibility for all risks associated with participation in the sport, and I do hereby fully release, hold harmless and discharge the Lynbrook Titans, and its board members, officers, directors, employees, agents, consultants, coaches, volunteers, sponsors, and representatives (collectively referred to herein as "Releasees") from and against all claims, actions, proceedings, liabilities, losses, damages and expenses (including but not limited to legal fees) (collectively referred to herein as "Claims") related directly or indirectly to property damage, personal injuries, or other claims arising from or in connection with my child's participation in the program or the use of the Titans' equipment, whether the result of negligence or any other cause, including claims that are known or unknown, foreseen and unforeseen, future or contingent. I further agree that I will not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against the Lynbrook Titans or any of the Releasees arising out of or in relation to the actions, causes of action, claims and demands hereby waived, released or discharged by me.

I hereby grant and release to the Lynbrook Titans the right and authority to use, reproduce, and distribute my child's photograph, likeness, recorded voice or videotaped appearances obtained in connection with my child's participation in the designated Titans program for promotional and marketing purposes or programs, including the Titans' website, social media associated with the Titans, yearbook, and/or journal, as the Titans in its sole discretion deems appropriate, for an unlimited duration and without compensation from the Titans.

CODE OF CONDUCT FORM

Parents/Football Players and Cheerleaders

All football and cheerleading participants will abide by a Code of Conduct, which includes the provisions stipulated herein. If any of these rules are broken, The Lynbrook Titans Board shall have the authority to impose a penalty, including but not limited to, immediate suspension of participation rights in any or all further Titans or team activity.

Participants (players and cheerleaders)

As a participant in the Titans activities and events, I shall conform to the following:

1. Try my very best to support my team and be a team player and always put the team first.
2. Remain within the team area of the sidelines during games.
3. Accept my coaches' teaching and be ready to learn and to have fun.
4. Listen to the coaches and follow the rules of the Titans.
5. Demonstrate good sportsmanship on and off the field of play.
6. Will show respect towards all coaches, players, referees, and other parents.
7. Will not fight, use foul language or argue with coaches, teammates, or referees.

Parents/guardians and activity/event attendees

We are expected as parents/guardians to conduct ourselves in a civil and respectful manner at Lynbrook Titans activities and events, and that failure to do so may result in fines and other sanctions up to and including expulsion of me and my family from the Titans and other possible sanctions. As a parent/guardian and/or attendee at Lynbrook Titans activities and events, I shall conform to the following:

1. I am not allowed on the football field during practice or any game day and shall not attempt to approach any field areas.
2. It is my responsibility to clean up after myself at the practice field and game field.
3. I am responsible for the behavior of anyone I bring to practice, games, events, and activities.
4. I am not allowed to consume alcoholic beverages or use any tobacco products on the property where any game, practice, or other event is being held.
5. I will not use abusive or foul language or display any signs of aggressive and abusive behavior towards the coaches team staff, teammates, other parents/participants, or Titans Board.
6. I will always represent the team and the Titans in a positive manner.
7. I will address problems, issues, and concerns in a respectful manner with the team's head coach and/or the Titans Board.
8. I will demonstrate a supportive and positive attitude for all players, coaches, opponents, administrators, and officials.
9. I will accept the results of each game, focusing on the children's efforts and performance.
10. I will respect the rights and dignity of all participants, players, coaches, fans and officials regardless of race, sex, creed or ability. I understand that behavior that degrades or otherwise constitutes discriminatory or inappropriate conduct toward a player, coach, referee, or other parent based on race, sex, creed or any other reason is subject to disciplinary action by the team and/or Titans Board.
11. I understand that my attitude toward my child, other team members, the opposing team, officials, and the coaches influences my child's values and behavior in sports. Criticism and disrespect undermine the purpose of sports.

Playing Time Policy

To ensure fairness and reward dedication, playing time is directly tied to practice attendance:

1. Full Attendance (3 practices/week): Guaranteed at least 6 plays per game.
2. Partial Attendance (2 practices/week): Guaranteed at least 4 plays per game.
3. Limited Attendance (1 practice/week): Guaranteed at least 2 plays per game.
